# SAFETY STATEMENT

### Policy

It is the policy of the Cork City Regatta Committee to encourage water safety awareness during the event. The safety of competitors, spectators, CHOR officials and volunteers is given the highest priority in the organising and the running of the Head. Safety will be assured through the implementation of the Safety Plan.

### Objectives

The Safety Plan had six main objectives:

- 1. Our goal is to have zero accidents.
- 2. To ensure that racing is conducted with due observance of all safety conditions in Rowing Ireland's Rules of Racing.
- 3. To manage hazards specific to Cork Head of the River course on the River Lee.
- 4. To provide adequate First Aid and medical services at the regatta course.
- 5. To investigate any incidents of a hazardous nature which occur during the Head.
- 6. The Regatta Committee has appointed a safety officer who will take overall responsibility for co-ordination and execution of the Safety Plan.

### Responsibility

In accordance with the current guidelines, it is the responsibility of each participating Club Committee to ensure the safety of their members while participating. References include:

- The Department of the Marine and Natural Resources
- The National Safety Council
- The Irish Sailing Association
- The Irish Amateur Rowing Union

### Intent

It is the intention of the Organising Committee to implement its own policy and to provide example to participating Clubs by creating a positive Safety Environment during the event.

### Method

Safety awareness will be promoted by:

- 1. Informing Club Secretaries of the event rules in advance by correspondence
- Holding a captains, coxes and coxless crews safety meeting prior to the event on Thursday 20<sup>th</sup> Feb at 7:30pm online via Zoom.
- 3. Slip Marshals ensuring crews to check their boat safety features.
- 4. Appointing Safety Marshal Launches as required on the river, per Appendix A.
- 5. Providing Rescue Launch Rib from Cork Search and Recovery, positioned midway on the course.

### Marshals

Marshals are requested to assist voluntarily in the safe running of the event by

- 1. Providing a presence on the river, per appendix A.
- 2. Marshalling crews to the start in a prompt and orderly manner and return to slipping area when finished.
- 3. Giving information to the other river users
- 4. Assisting crews in the event of equipment failure, collision, or an accident

Marshals are concerned with encouraging the Safety of

- 1. Themselves
- 2. Competitors
- 3. Event Organisers
- 4. Other River users

### Marshals Safety Code

- 1. Be aware of the weather forecast for the day.
- 2. Check your engine, oars, oarlocks, bailer, fuel tank, bung, and painter to ensure that they are secured properly and in good working order. It is good practice to carry alternative source of propulsion.
- 3. Carry out a visual inspection of the hull for damage.
- 4. Ensure that each person onboard wears a lifejacket or buoyancy aid.
- 5. Check the propeller for dents and nicks which could cause the engine to vibrate.
- 6. Wear the engine "dead-man" cord at all times of operation.
- 7. Make sure that nobody is standing in the water near the propeller and that no one is standing behind you when pulling the starting cord.
- 8. Consult the handbook if in doubt about operation of the engine, carburettor flooding or any other issue such as tilting mechanism as these are necessary skills in the event of a rescue of rowers.
- 9. When the engine fires check the cooling water tell-tale and allow the engine to run for a few minutes before closing the choke.
- 10. Make a visual check to ensure that you have sufficient fuel.
- 11. Forbid horseplay and never drink alcohol.
- 12. Do not carry more that the authorised number of passengers in your boat as recommended by the manufacturer.
- 13. Make sure that you co-ordinate your movements on the river with the needs of the Water Co-ordinator and keep in regular communication.

### **Crew Safety**

It is the responsibility of each participating club to ensure that their competing crews are competent to participate in the grade for which they are entered. On the Thursday evening prior to the event, the cox or steer person must attend the coxes meeting online and register their attendance. This meeting will include a safety brief. A map of the river included in the programme or provided separately, see Appendix B.

All equipment must comply with the I.A.R.U. Safety regulations; especially bow balls and heel straps.

### **Boat Accident Recovery Procedure**

- 1. Approach the recovery location from downwind where possible.
- 2. Inform other marshals in the area and Race Control immediately so that onshore services can be altered.
- 3. Secure the recovery craft to the bow or stern of the boat requiring assistance.
- 4. Stop the engine before giving further assistance due to danger from the propeller.
- 5. Recover the persons in the water over the stern only.
- 6. After recovery more persons needing assistance to the nearest of the following locations:
  - Start Area
  - Slip Areas
  - The South bank of the Head Course, the Marina side.
  - Finish Area

The safety of competitors, event organisers, spectators and other river users is the priority activity. Unless abandoned boats or equipment represent a hazard to others their recovery should be left until after the event when river traffic has eased.

### **First Aid and Medical Services**

On site First Aid personnel and ambulances, will be available at Lee Rowing Club and Cork Boat Club, at designated areas for the duration of the Head.

### **Course Choice**


The 4km course is from Andersons Quay, North side of river after split, to Blackrock Castle. See Appendix A and B.

In the event of poor weather conditions beyond Blackrock Village then the course will be shortened by moving the finish line to Cork Boat Club. Should this be the case all club captains will be notified of the change in advance.


